Acquisition of an additional 30% stake in an Indonesia's Life Insurance Company: PT Asuransi Jiwa Sinarmas MSIG Tbk by Mitsui Sumitomo Insurance

Mitsui Sumitomo Insurance Co., Ltd. (President: Noriyuki Hara, "MSI"), a member of MS&AD Insurance Group, has acquired an additional 30% stake of common stock in PT Asuransi Jiwa Sinarmas MSIG Tbk ("AJSM"), one of the major life insurance companies in Indonesia, for approximately 3.8 trillion rupiah (approx. 29 billion yen*). After this acquisition is completed, MSI will own 80% in AJSM. AJSM is going to be listed today on the Indonesia Stock Exchange.

MSI will continue to further strengthen its operation in Asia, aiming for sustainable development of its international business.

2. Background and purpose

Indonesia's life insurance market, which has been growing with its average growth rate of 15% for the last five years, is expected to further grow in the future with its world 4th population (260 million) and demographic dominated by large young generation.

MSI acknowledges AJSM's role as a strategic business and it is expected that AJSM can accelerate its growth, noting MSI's cooperation with the Sinarmas Group, MSI's strategic partner in AJSM. MSI will further contribute to the popularization of insurance products as well as economic development in Indonesia.
