We have raised "Planetary Health" as our materiality in the medium-term management plan, and are tackling climate change.

We will contribute to the transition to net zero society through the development of international standards for decarbonization of insurance underwriting portfolios and supporting companies which respond to decarbonization.

### 1. Net-Zero Insurance Alliance (NZIA)
