## <u>Corporate Venture Capital Investment Operations Commence</u> <u>in Silicon Valley in the USA</u>

MS&AD Insurance Group Holdings, Inc. (the "Company", President & CEO: Yasuyoshi Karasawa) have established a corporate venture capital ("CVC") in Silicon Valley that will invest in start-up businesses worldwide. This CVC is the first CVC started in Silicon Valley by a Japanese insurance group and will commence investment operations with US\$40 million (approximately 4.5 billion Japanese Yen) in October.

By establishing this CVC, the Company's investment in start-up companies with cutting-edge technologies and new business models will be accelerated. Through its investment operations, the MS&AD Insurance Group will also become a member of the Silicon Valley ecosystem (\*). The Company will aim to improve the value of the customer experience while linking this investment with Company's Mission of contributing to a vibrant society through the reform of the Group business as a whole.

\* Silicon Valley ecosystem: a community where entrepreneurs, investors, companies, experts, and scholars gather and create new industries, businesses, technologies, etc.

In February 2017, the Company commenced investment in a fund of funds operated by Net Service Ventures Group in the US in order for the entire MS&AD Group to be able to utilize the information obtained by various Silicon Valley investors about cutting-edge technologies and new business models. Along with dispatching of the representative to Silicon Valley since May 2017, in January 2018 we began the "MS&AD Garage Program," a program in which Group employees in Japan and worldwide stay a few weeks or a few months in Silicon Valley to discover start-up companies that can solve problems for each own operation.

The Company has decided that in order to provide innovative products and services that respond quickly to the changing needs of society, it is important to build a corporate structure for investing in superior start-up companies with which we can create new business opportunities and help start-up companies succeed in many markets around the world.

Through the operation of this CVC, the Company intends to strengthen further our competitive edge in the global market by investing in companies that are helping to build a sustainable future and developing globally innovative products and services.
